The course will provide students with a basic understanding of women's political history and an overview of women's contemporary political behavior. Successful students will develop an analytical framework for understanding current debates about gender roles and women's political participation.

Class Participation

Twenty percent of your grade is based on participation. Your participation grade will be based on quizzes, your participation in class discussion, and your participation in small group work during class. Make-up exams will be given without penalty only under dire circumstances. If you have a university-approved

absence, you must discuss your situation with me prior to the scheduled examination. In the event of an illness on exam day, documented proof of the illness is required to discuss taking a make-up examination. I reserve the right to change the format and questions on the makeup exam.
