State Government Internship Program

About the Office

The Ohio State Office of Government Affairs works to build and support productive relationships with public officials and their staff. The team works regularly with members of Congress, Governor's Office, Mayor's Office, Ohio General Assembly, Columbus City Council, and other federal, state, and local agencies on legislative, regulatory, and budget actions impacting the University and the higher education community.

About the Internship

The State Government Internship Program is coordinated through a partnership of The Ohio State University Office of Government Affairs and Department of Political Science. It provides sophomores, juniors, and seniors with a semester-long internship with the Ohio General Assembly. Students selected for the program will be placed in the office of a State Representative, State Senator, or caucus policy office in downtown Columbus and have the option of earning 3 hours of credit for their work. The program also offers 3 seminars focusing on distinct aspects of working in state government.

Assignments vary from office to office, but students can expect to work on things like assisting with the resolution of constituent issues, identifying constituent and community achievements for recognition, conducting research, drafting letters and memos, and attending committee hearings and sessions. In addition, the program provides the opportunity for exposure to policymaking in action and the chance to interact with public officials and government staff. Transportation is not provided; however, the Ohio Statehouse is a stop on several COTA bus lines, which requires only an active student BuckID.

Finalist will be notified on Friday, August 7, 2025, of their selection into the program. Finalists will have until Tuesday, August 12 2025 to accept or decline the offer. Selected students can accept or decline the offer and begin their internship experience.

Gluck-Asher Financial Award

Five students will be selected to take part in the internship program and will be eligible for a one-time \$1000 award credited to their student account at the end of the semester if they successfully complete all internship program requirements and earn at least a B in the appropriate section of Political Science 4191. This award is made possible through the generous donation of Ohio State alumnus Barry Gluck. Mr. Gluck generously donated in honor of Professor Emeritus Herb Asher to support students interested in starting a career in public service. Please note that the stipend can only be awarded up to the cost of attendance.

Program Requirements

Students are expected to spend 10-15 hours per week on site at their internship in blocks of 4-5 hours. Availability on Tuesdays and Wednesdays is a plus but not required. Program requirements include attendance at a pre-internship orientation; attendance at 2 out of 3 seminars that highlight various aspects of working in state government; completion of an internship agreement form, and to complete all assignments as outlined in the 4191 syllabi.

Qualifications

The State Government Internship Program is open to students of any major who have obtained at least a 3.0 grade point average and have completed at least one year on Ohio State's Columbus campus.

How to Apply

Applications are due by **Sunday**, **August 3**, **2025**, along with a copy of the class schedule for the semester in which you will intern, and a resume, as well as a personal statement (included on the application form).

Mr. Gluck has a long-held passion for service and founded the Fallen Angels Foundation in 2002. The foundation, where he serves as Managing Director, focuses on helping abandoned, battered, and abused women, children, and animals.

In addition, Mr. Gluck also serves on several private boards of directors, including Assurance Global, INTURN, and others. He previously held positions as Executive VP for Ross Stores, Chief Merchandising Officer for Today's Man, and VP of Menswear/Kids/Luggage for Macy's.

Mr. Gluck earned his Bachelor of Science degree in Political Science from The Ohio State University. He is dedicated to using the knowledge and experience he has acquired throughout his career to help others, a value modeled from his time as a student and advisee of Dr. Herb Asher's in the early 1970s. Mr. Gluck developed the Gluck-Asher Financial Award to support students participating in the State Government Internship Program in 2015 to honor the professor and give back to the university that first spurred his interest in service.



Dr. Herb Asher is professor emeritus of political science at The Ohio State University, He previously served as counselor to the university president, Senior Vice President for Government Affairs, and earlier as special assistant to the university president for government relations and founding director of the John Glenn Institute for Public Service and Public Policy.

He is currently serving in the position of Retiree-Faculty Emeritus in the Office of Academic Affairs where his responsibilities include writing the history of The Ohio State University during the second Gordon Gee Administration and advising the University President on relevant political matters. Dr. Asher is frequently called upon as an expert political analyst by local and national media. He still teaches an occasional course on Ohio Politics and on Campaign Politics.

Dr. Asher earned his degrees at Bucknell University (B.S. Mathematics) and the University of Michigan (M.A. and Ph. D. in political science). He is the author of numerous books and articles on American politics.

Dr. Asher currently serves as faculty adviser to the College Democrats and previously served in this role to the College Republicans, Undergraduate Student Government, and to two fraternities. He also serves on the Executive Committee and Board of Trustees of Hillel.

Dr. Asher is a former member and chair of the Ohio Ethics Commission and is currently a member of the Mid-Ohio Regional Planning Commission, the United Way Public Policy Committee, and the Board of Equality Ohio. He is a former member of the Board of Trustees of Community Research Partners, a former member of the Board of Trustees of the Columbus Metropolitan Club, and former president of the Ohio State University Faculty Club.
