# **Syllabus**

This course will examine the formal institutions of Ohio government—executive, legislative, and judicial—and the political processes and actors that shape Ohio politics and policies—elections, political parties and interest groups. The course begins with a discussion of various factors that shape and constrain the choices available to our elected leaders. These include the Ohio Constitution, Ohio's political culture, Ohio's population distribution, Ohio's changing economy, and Ohio's relationship with the federal government. We next examine the executive, legislative and judicial branches of Ohio government. We will devote substantial attention to the Ohio budget process as well as to specific public policy issues such as the funding and regulation of primary and secondary education and of higher education. We will also examine briefly the structure and functions of local governments in Ohio. Finally, we will discuss the 2013-2014 election cycle in Ohio and the role of political parties and interest groups.

Students should gain from the course a basic knowledge of the nuts and bolts of Ohio government. More importantly, students should be able to analyze the performance of Ohio's government, explaining how and why Ohio government has performed effectively and ineffectively.

# **Course Requirements**

There will be a midterm exam, a final exam, and a paper; each counts one-third of the final grade. Students are, of course, expected to keep up with the readings and are strongly encouraged to participate in class discussions. The paper assignment is described at the end of the syllabus; note that there are three options for the paper.

# **Paper Assignment Option #1**

You are to write an analysis of the economic health of your home county covering the period from 1970 through 2011. You should also compare your home county to the state of Ohio as a whole so that you can address the question of how your county is doing relative to the entire state. If you are not from Ohio and want to do this paper, use Franklin County as your home county.

One indicator of economic health that you must examine is the unemployment rate in the county and the state. In addition, you must examine three other measures or indicators that might reflect the economic health of the county and the state. You will decide which three indicators to analyze. Your paper should make a number of comparisons. You should analyze how the county has done over time; the same analysis should be done for the state. You should also compare the county directly with the state over the 1970-2011 period.

The paper is due Tuesday, May 29. The paper should not exceed 8 double-spaced typed pages. Because the paper covers a 41 year span, you will need to devise efficient ways of presenting, describing, and commenting on your results. Charts, tables, and graphs might be good ways to present your data and results. Do not let your paper become simply a set

of numbers and statistics. Instead, make sure you provide discussion about the patterns and trends you uncover.

This is a challenging assignment so make sure you get started in a timely fashion. The paper will require you to make many choices about the kinds of data and evidence that are relevant to the assignment. Feel free to talk to me about the paper. Late papers will be penalized.

Let me suggest a few sources to get you started. Check out <a href="http://lmi.state.oh.us">http://lmi.state.oh.us</a> for labor market information. You might also do a Google search on <a href="Ohio County Profiles.">Ohio County Profiles.</a> There are many other sources available.

# **Paper Assignment Option #2**

You are to write a political/election history of your home county covering the period from 1976 through 2010. You should also compare your home county to the state of Ohio as a whole. If you are not from Ohio and wish to do this assignment, use Franklin County as your home county.

Your political/election history should focus only on contests for Governor and President in this time period. In focusing on gubernatorial and presidential races, you will first want to examine the vote choices (Democrat vs. Republican) made by citizens in the county and the state. How Republican or how Democratic is your home county? How has this changed over time? How does your home county compare with Ohio as a whole? In addition to addressing whether your county voted Democratic vs. Republican, you must also examine the turnout in the county and the state. What is the turnout rate for the county and the state? How has this changed over time? Finally, what share of the total state vote does your county cast? How has this changed over time?

The paper is due Tuesday, May 29. The paper should not exceed 8 double-spaced typed pages. Because the paper covers a thirty-four year span and is limited to 8 pages, you

will need to devise efficient ways of presenting, describing and commenting on your results. Charts, tables, and graphs might be good ways to present your data and results. Do **not** let your paper become simply a set of numbers and statistics. Instead, make sure you provide discussion about the patterns and trends you uncover.

This is a challenging assignment so make sure you get started in a timely fashion. Feel free to talk to me about the paper. Late papers will be penalized.

One good source for Ohio election data is the website of the Secretary of State of Ohio. There are also books (Ohio Election Statistics) published by the Secretary of State's office.

# **Paper Assignment Option #3**

You are to describe the taxing and spending policies of three government jurisdictions: your home county, your local public school district, and your home municipality (a city, township, village or whatever). You should describe the major funding (taxes, fees, other) sources for the general funds (operating) budget for all three jurisdictions. Also examine how the funding sources have changed over the last 20 years, perhaps by examining jurisdiction budgets every four years for the past twenty years. Make sure you indicate how the budget has changed over time with respect its size (dollars) and sources of those dollars.

Next, you are to describe how the budget dollars are spent in these three governmental jurisdictions. What are the major spending areas? How have these changed over time? Try to identify broader spending categories and see how their share of the budget has changed over time. Examine a twenty year period, perhaps by examining jurisdiction budgets every four years.

If you are from Ohio, analyze your home school district, your home county, and your home municipality. If you are not from Ohio, then use Franklin County, Columbus, and the Columbus school district as your three jurisdictions. The paper is due Tuesday, May

29. It should not exceed 8 double-spaced typed pages. You will need to devise efficient ways of presenting, describing and commenting on your results. Charts, tables, and graphs might be good ways to present your data and results. Do **not** let your paper become simply a set of numbers and statistics. Instead, make sure you provide discussion about the patterns and trends you uncover.
